CIRCULAR

Dear Comrades,

Congratulations and Red salutes to all the Comrades who made the one day strike on 02-09-2015, a grand success. The Joint Council of Action, A.P & TS places on record the whole hearted support given by the members for the strike call. The strike has blowing effect on the Government. The Government has announced that it is ready to accept 9 of the 12 demands of the workers on the labour reforms and willing for discussion on the other demands also. Comrades, this is a remarkable development and initial victory for all our fraternity.

Coming to the Departmental issues, you are all aware that the Joint Council of Action, New Delhi has called for the agitation program in pursuit of the following long pending legitimate demands:

1. Promotion in the cadre of ACIT, for all regular and Cadre Restructure vacancies and upto the Recruitment Year 2015-16, are to be given immediately.
2. Provide infrastructure facility to all Officers and Officials i.e., ample space with modern furniture, Computers with nodes, etc.,
3. Steps to be taken to fill up all vacant posts immediately and to stop outsourcing of regular office work/data entry work
4. To regularize all casual/daily paid workers against MTS posts, who are completing 10 years as on date in our Department
5. Finalise and notify all Recruitment Rules of Group B & C immediately.


The Joint Council of Action, New Delhi has called for the following agitation program in pursuit of the above demands:


1. Lunch hour demonstration will be held on 09-09-2015 before Pr.CCIT and other CCIT/CIT offices/stations.


The non-cooperation movement will start from 09-09-2015 itself in the following manner:

- (i) Stoppage of work relating to widening of tax-base
 - (ii) No work relating to I & CI job like uploading CIB data, disposal of verification cases etc.,
 - (iii) Artificial deadlines for completion of scrutiny assessments will not be adhered to.
2. Black-flag demonstration before the Chairperson and Members of CBDT on their visit in any office outside the North Block
 3. Day long dharna in front of all Pr.CCIT and other CCIT/CIT offices on 15-09-2015
 4. Half-day walk-out from 2.00PM on 24-09-2015.
 5. Strike action on 8th October, Thursday, 2015.

Comrades, the Cadre Restructure Plan was approved by the Government in May, 2013 i.e., two years ago but our legitimate and just demands are still pending. The apathy of the Board towards our just demands is forcing us to take the path of agitation and we have to fight hard and demonstrate our strength, to mend the attitude of the Board. Therefore, all the members of ITGOA, ITEF, ITEF(MTS) are requested to make the agitation program a grand success.
