PROCEDURE :

1. All the primary members of ITEF are eligible to vote and contest as Delegate.
2. Mode of election is by secret ballot.
3. Each member shall elect **39** members as delegates from among the contestants. If any member puts tick mark for more than **39** contestants, his ballot would be treated as invalid.
4. The Election Commission's decision is final with regard to the conduction of elections.
5. Defective nominations would be summarily rejected without giving any opportunity.
6. Nominations and withdrawal of nominations should be in the prescribed form. The nominations & withdrawal forms can be obtained and filed with any of the Asst. Election Officer mentioned above at their respective offices on all working days.
