2. The following conditions should be mentioned in the promotion order to be issued by the appointing authority mentioned at column No. 3 above.

- a) Those officers, in whose cases financial upgradation under ACP to the scale of ITO (i.e., 7500-250-12000) has already been granted, will not be eligible for pay fixation consequent to this promotion.
- b) Their promotion is purely provisional
- c) They will be liable for reversion –
  - (i) if after a review of the vacancies, it is found that their promotions are in excess of the vacancies available or any candidates omitted for any reason becomes eligible for promotion subsequently.

- d) Their promotions to the cadre of Incometax Officer, Group 'B' [Gazetted] are subject to the outcome of the Hon'ble High Court's decisions in Writ Petition No's 25202 of 2009, 25203 of 2009, 22046 of 2009, 22084 of 2009, 22087 of 2009 and W. P. M.P.No.37426 of 2009 in W.P.No.28814 of 2009 and shall also be subject to the result of O.A No.1092 of 2009 of Hon'ble CAT, Hyderabad.
- e) Their promotions as Income Tax Officer, Group 'B' (Gazetted) are subject to the outcome of the decisions in various applications / petitions pending, if any, before Hon'ble High Court / Hon'ble CAT of Andhra Pradesh and Courts of India other than those mentioned at (d) above.
- f) Their attention is invited to MHA's O.M. F. No. 7/1/80-Estt-P.1 dated 26/09/1981 regarding exercising of option for fixation of pay on promotion.
- g) Their promotion / *inter se* seniority are subject to the outcome of Supplementary / Review DPC, if any, and placement of their position as per the reservation roster.
- h) Their seniority will be liable for re-consideration / re-fixation in the event of any claims of seniority that may be filed at any point of time, upon being found, with reference to the records that the claim is / are correct.
