c) Their promotions as Office Superintendents are subject to the outcome of the decisions in various applications / petitions pending before the CAT/Court.

d) The attention of the promoted officials is invited to MHA's O.M. F. No. 7/1/80-Estt-P.1 dated 26/09/1981 regarding exercising of option for fixation of pay on promotion.

e) their seniority in the cadre of will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.

3. If the pay of the officials has already been upgraded under ACP scheme, then they will not be eligible for pay fixation consequent to this promotion.

4. The officials retained at their present place of posting have been retained only upto Annual General transfers 2010 to avoid dislocation of time barring work at present. Their names shall be considered afresh for any place / office at the time of AGT 2010.
