2. The following conditions should be mentioned in the promotion order issued by the appointing authority:-

- a) Their promotion is purely of ad-hoc nature and;
- b) They will be liable for reversion without any prior notice.
- c) They will be liable for reversion -
 - (i) if after a review of the vacancies, it is found that their promotion is in excess of the vacancies available;
 - Or
 - (ii) if found unfit for retention in the post of Stenographer Grade-I
- d) Their promotion as Stenographer Grade-I are subject to out come of any Cases pending before the Hon'ble CAT /other Courts.
- e) The attention of the promoted officials is invited to MHA's O.M. F. No.7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No. 1/1/2008 regarding exercising of option for fixation of pay on promotion.

- f) His/her seniority in the cadre of Stenographer Grade-I will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.
- g) His/her appointment shall not confer any right to them for continued officiating or seniority or for regular promotion and shall be governed by the instructions of DOP&T as contained in O.M. no. 28036/8/87-Estt. (D) dated 30.03.1988 and instruction issued by Government from time to time
- h) His/Her promotion is subject to outcome of recasting of reservation rosters in the cadre of Stenographer Grade-I in accordance with DOP&T's O.M. No. 36012/45/2005-Estt(Res.) dated 10.08.2010.
- i) The official will not be eligible for pay fixation consequent to this promotion in case his/her pay has already been upgraded in the scale of Stenographer Gr. I (PB - 2) under ACP Scheme/MACP Scheme.
- j) The above promotions to the cadre of Stenographer Gr. I are on in-situ basis

3. The promotion order should be issued in the prescribed proforma immediately.

4. **Postings of the above mentioned official will be reviewed during the Annual General Transfers, 2015.**
