

2. The following conditions should be mentioned in the promotion order issued by the appointing authority:-

- a) Their promotion is purely provisional;
- b) They will be liable for reversion -
 - (i) if after a review of the vacancies, it is found that their promotion is in excess of the vacancies available;
 - Or
 - (ii) if found unfit for retention in the post of Stenographer Grade-II (PB-II)
- c) Their promotion as Stenographer Grade-I are subject to out come of any Cases pending before the Hon'ble CAT and Hon'ble Courts.
- d) Their promotion as Stenographer Grade - I are subject to outcome of decision by the Hon'ble CAT in O.A no. 020/00557/2014 dated 02.01.2015.
- e) The attention of the promoted officials is invited to MHA's O.M. F. No.7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No. 1/1/2008 regarding exercising of option for fixation of pay on promotion.

- f) His/her seniority in the cadre of Stenographer Grade-I will be liable for revision at any point of time, if any bonafide mistake is found with reference to any records.
 - g) His/Her promotion is subject to outcome of recasting of reservation rosters in the cadre of Stenographer Grade-I in accordance with DOP&T's O.M. No. 36012/45/2005-Estt(Res.) dated 10.08.2010.
 - h) The official will not be eligible for pay fixation consequent to this promotion in case his/her pay has already been upgraded in the scale of Stenographer Gr. I under ACP Scheme/MACP Scheme.
 - i) The above promotions to the cadre of Stenographer Gr. I are on in-situ basis
3. The officials concerned may also note that the service rendered by them as ad-hoc Stenographer Gr. I in pursuant to this office Memorandum of even no. dated 31.12.2014 shall not be counted for the purpose of seniority or for promotion to next higher cadre.
4. The promotion order should be issued in the prescribed proforma immediately.
5. **Postings of the above mentioned official will be reviewed during the Annual General Transfers, 2015.**
6. This issues with the approval of the Pr. CCIT, Andhra Pradesh & Telangana.
