2. The following conditions should be mentioned in the promotion order to be issued by the appointing authority mentioned at Column 3 above.

- a) Those officers, in whose cases financial upgradation under ACP to the scale of ITO (i.e., 7500-250-12000) has already been granted, will not be eligible for pay fixation consequent to this promotion.
- b) Their promotion is purely provisional.
- c) They will be liable for reversion –
 - (i) if after a review of the vacancies, it is found that their promotions are in excess of the vacancies available or any candidate omitted for any reason becomes eligible for promotion subsequently.
 - or
 - (ii) if their performance is found to be non-satisfactory in the post of Income Tax Officer.
- d) Their promotions to the cadre of Incometax Officer, Group 'B' [Gazetted] are subject to the outcome of the Hon'ble High Court's decisions in Writ Petition No's 25202/2009, 25203/2009, 22046/2009, 22084/2009, 22087/2009 and W. P. M.P.No.37426 of 2009 in W.P.No.28814 of 2009 and O.A No.1092 of 2009 of Hon'ble CAT, Hyderabad.
- e) Their promotions as Income Tax Officer, Group 'B' (Gazetted) are also subject to the outcome of the decisions in various applications/petitions pending, if any, before CAT/Courts other than those mentioned at (d) above.
