

2. The following conditions should be mentioned in the promotion order to be issued by the appointing authority:-
- Their promotions are purely provisional.
 - They will be liable for reversion –
 - if after a review of the vacancies, it is found that their promotions are in excess of the vacancies available;
 - if found unfit for retention in the post of Inspector of Income Tax.
 - The attention of the promoted officials is invited to MHA's O.M. F. No. 7/1/80- Estt-P.1 dated 26/09/1981 and the Ministry of Finance, Department of Expenditure (Implementation Cell) O.M. in F.No. 1/1/2008 regarding exercising of option for fixation of pay on promotion.
 - Their promotion and seniority in the cadre of Income tax Inspector will be liable for revision at any point of time subject to seniority made in accordance with (i) OA No.598 of 2013 filed by Sri RSR Chandra Murthy and OA No. 1325 of 2013 filed by Sri Manas Ranjan Behera filed before Hon'ble CAT (ii) Outcome of the OA No. 557 of 2014 filed by Sri G Maruthi Prasad and others before the Hon'ble CAT, Hyderabad Bench; (iii) Out come of any other cases pending before the Hon'ble CAT/other Courts.
 - This promoting order is subject to the result and outcome of recommendations of N.R. Parmar Committee constituted in this region.
 - Further, their seniority will also be liable for revision, if any bonafide mistake is found with reference to any records
 - The above promotions to the cadre of Inspector of Income Tax are on *in-situ* basis.
3. If the pay of the officials has already been upgraded under ACP/MACP scheme, then they will not be eligible for pay fixation consequent to this promotion.
4. The promotion order should be issued in the prescribed proforma immediately.
5. **Postings of the above mentioned officials will be reviewed during the Annual General Transfers, 2015.**
6. This issues with the approval of the Principal Chief Commissioner of Income Tax, Andhra Pradesh & Telangana.
