2. The following conditions should be mentioned in the promotion order issued by the appointing authority:-

- a) Their promotion is purely provisional;
- b) They will be liable for reversion -
 - (i)if after a review of the vacancies, it is found that their promotions are in excess of the vacancies available;
 - or
 - (ii)if found unfit for retention in the post of Office Superintendent
- c) Their promotions to the cadre of Office Superintendents is subject to the outcome of Hon'ble High Court's decisions in Writ Petition No. 25202/2009, 25203/2009, 22046/2009, 22084/2009, 22087/2009 and W.P. M.P. No. 37426 of 2009 in W.P. No. 28814 of 2009 and W.P. No. 7118/2009 and O.A. No. 1092 of 2009 of Hon'ble CAT, Hyderabad
- d) Their promotions as Office Superintendents are subject to further orders that may be passed by the CAT/Courts.
- e)The attention of the promoted officials is invited to MHA's O.M. F. No. 7/1/80-Estt-P.1 dated 26/09/1981 and Ministry of Finance, Department of Expenditure (Implementation Cell) O.M.F.No.1/1/2008-IC dated.13.09.2008 regarding exercising of option for fixation of pay on promotion.
- f) their seniority in the cadre of will be liable for revision at any point of time if any bonafide mistake is found with reference to any records.
- g. If the pay of the officials has already been upgraded under ACP scheme, then they will not be eligible for pay fixation consequent to this promotion.
- h. The Officials are retained in their present place of posting upto Annual General Transfers(AGT)'2010 only. Their names shall be considered afresh for any place/office at the time of AGT,2010.**
