2. The following conditions should be mentioned in the promotion order to be issued by the appointing authority :

- a) their promotion is purely provisional
- b) they will be liable for reversion,
 - i) If, after a review of the vacancies, it is found that their promotion is in excess of the vacancies available;
 - ii) If they are found unfit for retention in the post of Private Secretary, (Group-'B'-Gazetted).
- c) their promotion/appointment as Private Secretary is subject to the outcome of CAT/Court's Order, if any.

- d) their attention is invited to MHA's O.M. in F.No.7/1/80-Estt.P.I dated 26.09.1981 read with CCS (Revised) Pay Rules, 2008 regarding exercising of option for fixation of pay on regular promotion.
- e) The official whose pay has been upgraded in the scale of Private Secretary (Group-'B'-Gazetted) under ACP / MACP Scheme will not be eligible for pay fixation consequent on this promotion.
3. i) The seniority of Sri Shaik Md Rafatulla and Smt. Kalpana Periyala is fixed between Sri Murali Ankari and Smt. Jyothsna Dasari.
- ii) Sri Shaik Md Rafatulla is senior to Smt. Kalpana Periyala.
